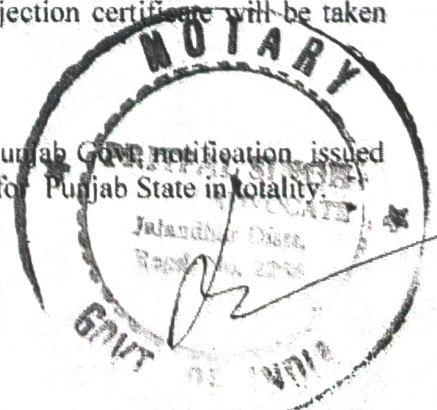

1. That in future at the time of any complaint/inspection if it is found that the no objection certificate has been taken on the basis of false information and wrong application or the terms and conditions of Punjab Govt. issued from time to time are not obeyed, the conditions of affidavit are not adhered to, this No Objection Certificate may be taken back at any time.
2. That Punjabi will be compulsory upto 10<sup>th</sup> class in your school and C.B.S.E. New Delhi will be responsible for making arrangement for Punjabi Examination and if not abided by, the no objection certificate will be taken back.
3. The school management will follow the Punjab Govt. notification issued under RTI Act 2009 and the RTI Act 2009 for Punjab State in totality.

4. That after the affiliation with C.B.S.E. New Delhi, the school management will be responsible for paying the teaching and non-teaching staff the salary and other allowances as per Govt. employees through account payee cheques. If not abided by, the no objection certificate will be taken back.
5. You yourself and the management will confirm that any information required by the District Education Officer or Education Department or any other Senior Officer, at any time, will be provided without any delay and suitable co-operation will be provided as applicable.
